## World Traders of the Year Nomination

### GENERAL SELECTION CRITERIA

- The World Trader of the Year Awards fall into 3 categories:
  1. Academic (Individual or Institution) or Organization
  2. Individual
  3. Business
- If the nominee is a business, or an organization, the recipient must be located (but not necessarily headquartered) in the West Michigan area. They do not have to be a member of the WMWTA.
- Members of the WMWTA Board of Directors and their employers are not eligible for consideration for the award.
- Recipients of the award within the previous five years are not eligible for consideration.

### INDIVIDUAL

For the INDIVIDUAL category, the following will be considered in addition to the general selection criteria:

- A demonstrated commitment to a career involving international trade. A minimum of three years in international trade is required.
- A demonstrated willingness to share time and talent in promoting international trade. Items to be considered: participation in the World Trade Association, participation in international programs, published author on trade, etc.
- Has demonstrated an interest in continuing to learn about international trade through continued training (i.e. attending international seminars).
- Actively promotes the purposes of the West Michigan World Trade Association and encourages new membership.

### BUSINESS

For the BUSINESS category, the following will be considered in addition to the general selection criteria:

- A demonstrated commitment to international trade. A minimum of a five-year history in international trade.
- Must conduct business in several foreign countries (i.e. direct, licensee, subsidiary, dealer, joint venture).
- Any innovative approaches to international trade will be viewed positively, such as adapting a product to a specific market.
- Clearly demonstrated intentions to broaden its international trade.

### ACADEMIC (Individual or Institution) OR ORGANIZATION

For the Academic or ORGANIZATION (i.e. government entity, learning institution, or nonprofit entity) category, the following will be considered in addition to the general selection criteria:

- A demonstrated commitment to international trade. A minimum of a three-year period that it has supported or promoted international trade.
- Support and promotion of international trade must be for a broad range of international trading partners.
- Support and mentorship of students and companies pursuing international trade.
